Sandy Oaks Raceway Member Rules

All riders **must** have a valid membership and the day waiver must be signed.

DO NOT RIDE ALONE!

It is the rider's responsibility to determine which obstacles are within their ability. **Ride at your own risk and never ride alone.** All Riders must ride slowly (1st gear) in the pit/pedestrian/parking area. No wheelies, stunts, doughnuts, etc. in the pit/pedestrian/parking area. Be sure to enter the track at a safe point and travel in the correct direction. Never stop on the track, especially near jumps. If you wish to take a break or leave the track you must do so at the exit point. In the case of an emergency, stop or exit the track at the nearest safe area. All riders must wear an approved full face motorcycle helmet whenever operating an OHV (including pit bikes) in the park. Motocross designed boots are mandatory for riders on 60cc bikes and bigger. It is expected that riders utilize other appropriate protective clothing/gear when riding in the park. Riders are PROHIBITED from consuming or being under the influence of ALCOHOL or DRUGS while riding. Minors must be under the control and supervision of a parent or responsible adult at all times while riding the track. Spectators are to remain in designated areas. There is no crossing the track or viewing from the medians. Place your trash in an appropriate bin or remove it when you leave the park. Automobiles must remain in the pit-parking area. Watch out for younger riders on the track. Pass with CAUTION!!! Beginners, hold your line when faster riders are approaching, they will go around you. Do not try and move out of the way, you may cause a collision. Riding is only permitted DUSK TO DAWN. Respect and follow all rules of the track. Lock gate after entry and exit to the track. Do not permit non-members to ride inside the gate. Sharing lock code and/or key is not permitted. Respect all members. Membership privileges will be revoked if these rules are not followed. For Day Pass holders' additional day passes or membership sales will be denied if the above are not followed.

Sandy Oaks Enterprises LLC RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

(READ CAREFULLY BEFORE SIGNING)

IN CONSIDERATION of being permitted to compete, officiate, observe, work for, or participate in any way in the Sandy Oaks Enterprises LLC sanctioned event "EVENT(S)" or being permitted to enter for any purpose any RESTRICTED AREA (defined as any area requiring special authorization, credentials or permission to enter or any area to which admission by the general public is restricted or prohibited including but not limited to the competition area and any hot pit area), THE UNDERSIGNED, for himself/herself, his/her personal representatives, heirs, and next of kin:

1. Acknowledges, agrees, and represents that he/she has or will immediately upon entering any such RESTRICTED AREAS, and will continuously thereafter, inspect the RESTRICTED AREAS which he/she enters and he/she further agrees and warrants that, if at any time, he/she is in or about RESTRICTED AREAS and he/she believes anything to be unsafe or unsatisfactory in any way, he/she will immediately advise the officials of such and will leave the RESTRICTED AREAS and/or refuse to participate further in the EVENT(S). I acknowledge that I may not have the opportunity to inspect any RESTRICTED AREA prior to the event.
2. HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE the promoters, participants, racing associations, sanctioning or administrative organizations or any affiliated entities thereof, track operators, track owners, officials, vehicle owners, drivers, builders and designers, crews, rescue personnel, any persons in any RESTRICTED AREA, promoters, sponsors, equipment and parts manufacturers and suppliers, advertisers, owners and lessees of premises used to conduct the EVENT(S), premises and event inspectors, surveyors, underwriters/brokers, consultants and others who give recommendations, directions, or instructions or engage in risk evaluation or loss control activities regarding the premises or EVENT(S) and for each of them, their directors, officers, agents, and employees, all for the purposes herein referred to as "RELEASES", FROM ALL LIABILITY TO THE UNDERSIGNED, his/her personal representatives, assigns, heirs, and next of kin, FOR ANY AND ALL LOSS OR DAMAGE, AND ANY CLAIM OR DEMANDS THEREFORE ON ACCOUNT OF INJURY TO THE PERSON OR PROPERTY OR RESULTING IN DEATH OF THE UNDERSIGNED ARISING OUT OF OR RELATED TO THE EVENT(S) WHETHER CAUSED BY NEGLIGENCE OF ANY RELEASEE(S) OR OTHERWISE.
3. HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the RELEASEES and each of them FROM ANY LOSS, LIABILITY, DAMAGE, FEES OR COSTS they may incur arising out of or related IN ANY MANNER TO MY ATTENDANCE AT OR PARTICIPATION IN THE EVENT(S), AND WHETHER CAUSED BY THE NEGLIGENCE OF ANY RELEASEE(S) OR OTHERWISE.
4. HEREBY ASSUMES FULL RESPONSIBILITY FOR ANY RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE arising out of or related to the EVENT(S) whether caused by the NEGLIGENCE OF ANY RELEASEE(S) OR OTHERWISE.
5. HEREBY acknowledges that THE ACTIVITIES OF THE EVENT(S) ARE DANGEROUS and involve risk of serious injury and/or death and/or property damage. Each of THE UNDERSIGNED also expressly acknowledges that INJURIES RECEIVED MAY BE COMPOUNDED OR INCREASED BY NEGLIGENT RESCUE OPERATIONS OR PROCEDURES OF THE RELEASEES.
6. HEREBY agrees that this Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement extends to all acts of negligence by the RELEASEES, INCLUDING NEGLIGENT RESCUE OPERATIONS and is intended to be as broad and inclusive as is permitted by the laws of the Province of State in which the EVENT(S) is/are conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

THIS AGREEMENT SHALL BE INTERPRETED UNDER THE LAWS OF THE STATE OF ILLINOIS. If any part of this Agreement is adjudged to be invalid for any reason, I agree that the remaining terms of the Agreement remain in full force and effect.

I hereby give up all my rights to sue or make any claim for damages due to negligence or any other reason whatsoever against the promoters, participants, racing associations, sanctioning organizations, Sandy Oaks Enterprises LLC, or any subdivision thereof, track operators, track owners, officials, vehicle owners, drivers, pit crews, rescue personnel, and any person in any RESTRICTED AREA, sponsors, advertisers, owners and lessees of premises used to conduct EVENT(S) or daily business on premises, and all other persons, participants or organizations conducting or connected with any event for injury to property or person I may suffer, including the contraction of the Covid-19 virus, crippling injury or death while participating in any event and while upon the premises. I know the risk of danger to myself and my property, while preparing for and participating in the event and while upon the premises, and relying upon my own judgment and ability, assume all such risks of loss and hereby agree to reimburse all cost to those persons or organizations connected with any event for damages incurred as a result of my negligence. I will also be responsible for any person (including children in my custody) or animals at my campsite or anywhere on the said premises while here at Sandy Oaks.

I HAVE READ THIS RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDESTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE OR GUARANTEE BEING MADE TO ME AND INTEND MY SIGNATURE TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.
